#### **Quality Learning, Student Success and Wellbeing:**

- Numeracy Report highlighted the strategies that are being implemented throughout the division to address gaps in learning and to support learners.
- The Board announced its five nominees for the Edwin Parr Teacher Awards and the Board forwarded Jenna Stumbur's (Duffield) name for the Alberta School Boards Association's Zone 2/3 nomination.

#### Trustees Engage, Listen and Advocate

- Design Funding has been approved for Spruce Grove Composite High School. This funding provides resources needed to bring the replacement school closer to the construction phase.
- Our Board will be formulating advocacy messages that reflect our local context and will provide those messages to School Councils.
- The Board approved the recommendation from the <u>School Naming Committee</u> which, after extensive community engagement, will see the replacement school for Stony Plain Central School be named **Westview School**.

#### Trustees Demonstrate Responsibility

- Trustees voted to approve the Fees and Allowances for the 2023-2024 school year, including the Transportation fees.
- Trustees approved the Three-Year Capital Plan. The two first year priorities are a replacement school for Spruce Grove Composite High School at a cost of \$70-80 million dollars and a new K-9 (900 capacity) School in Spruce Grove (East Side).
- Trustees received the Infrastructure Maintenance Renewal and the Capital Maintenance Renewal Plans. Work in progress for Muir Lake is the installation of heat/AC pumps for \$10,000 and the installation of acoustic paneling for \$8,000.
- Trustees received information on the relocation of Stony Plain Outreach and Spruce Grove Outreach Centres to the same site as Ecole Broxton Park School.
