The education plan aims to incorporate Comprehensive School Health and outdoor education, with high student interest in outdoor activities. # Electric school bus pilot projects in Alberta.

- The speaker's child was on a bus for an hour, and the driver was dealing with a situation involving a bag of shredded paper that had been dumped on top of other kids.

# Funding for specialist teachers in elementary schools.

• Bus drivers struggle with lack of funding for specialist teachers (Kim)

### School funding and public reporting.

- Unknown Speaker: School funding should be based on student needs, not school size.
- Unknown Speaker: Public reporting on school conditions is necessary for accountability.

### Public school data transparency in Alberta, including class sizes, staffing, and funding.

- Unknown Speaker: "Everything out in the sun, yeah? Disinfectant, which is, like, it's like..."
- Unknown Speaker: "We do not have accurate numbers on how our public schools are functioning in Alberta."
- Unknown Speaker: "It's wild, right? Why? Who wants to know that?..."

#### Mandatory literacy and emergency testing for kindergarten to grade 3 students.

• Kindergarten to grade 3 mandatory literacy and emergency testing is advocated for discontinuation by the Alberta School Council Association.

#### Literacy and numeracy assessments for schools.

• Unknown Speaker discusses literacy and numeracy assessments in schools.

# Education policy amendments in Alberta, including assessment tools and screening for learning challenges.
